- I am following all recommended guidelines as much as possible and limiting my exposure to the Coronavirus/COVID-19
- I hereby release and agree to hold TLC Driving School harmless from, and waive on behalf of myself, my heirs, and any personal representatives any and all causes of action, claims, demands, damages, costs, expenses and compensation for damage or loss to myself and/or property that may be caused by an act, or failure to act of the driving school, or that may otherwise arise in any way in connection with any services received from TLC Driving School. Permits are on HOLD due to Covid-19 at the following schools: IE Weldon Secondary School, Lindsay Collegiate and Vocational Institute and Fenelon Falls High School.

We want to instill a lifetime of safe and defensive driving habits for every customer that takes our course. Since driving is a learned skill, it is recommended that students schedule time to drive with a supportive parent or guardian outside of in car lessons. TLC Driving School is a Ministry Approved Beginner Driver Education course provider

Course includes 20 hours online e-learning, 10 hours online homework, 10 hours in-car training

Students **must** have their G1 before starting in-car training

Ministry of Transportation requirements:

- Drivers Ed must be completed within one year of course start date
- Minimum 40 hours of in-car practice before attempting the road test

70% is a pass; G2 drive test can be attempted after 8 months instead of 12.

Basic 1 package: \$1000 + HST = \$1130

In 2008, MTO implemented an online system; upon graduation final marks and personal information are entered into the Beginner Driver Education database. No paperwork is required for the G2 road test.

If an insurance company needs proof of completion of Driver's Ed; go to the Ministry Licensing office or www.serviceontario.ca and request a Driver's License History search. The fee is approximately \$12.50

It is advisable to sign up for a course as soon as the student has their G1. Driving instructors have a full schedule. Students can only progress at a rate that is suitable to their level of experience.

If a scheduled in-car session is missed, an additional fee of \$25 is charged. Instructors must be notified 24 hours in advance of a lesson cancellation
